1 BRAZIL IN THE GLOBAL INDUSTRY

Brazil is a vast country with over 11,000 film and audiovisual production companies registered in *Agência Nacional do Cinema* (Ancine). These companies are eligible to secure financial support for international co-productions through national and regional funds.

Historically, Brazil has been co-producing feature films with European countries since the 1960s, but it wasn't until the 2000s that there was a greater push for these partnerships, driven by new film policies, reaching new and potential co-producers across all continents.

The *Cinema do Brasil* program, established in 2006, has been one of the major initiatives promoting Brazilian cinema globally, connecting Brazilian and international producers at the world's largest film festivals and markets.

2 BILATERAL CO-PRODUCTION AGREEMENTS

Brazil has bilateral co-production agreements with 13 countries: South Africa, Germany, Argentina, Canada, Chile, Spain, France, India, Israel, Italy, Portugal, the United Kingdom, and Venezuela.

Most of these agreements have been updated in recent decades. In these agreements, the majority country can hold up to 80% of the rights, while the minority country must have at least 20%. This measure is the most common worldwide and facilitates the involvement of an international partner.

Each year, more Brazilian producers participate in international co-productions, not only as majority partners but also as minority partners, investing in projects by filmmakers from different parts of the world.

According to Brazilian law, in the absence of a formal agreement between Brazil and another country, the regulatory agency, *Agência Nacional do Cinema* (Ancine), may recognize the film as Brazilian (allowing access to Brazilian funding) if the Brazilian co-producer holds at least 40% of the film's rights. Additionally, two-thirds of the artistic and technical crew must be Brazilian or have lived in Brazil for at least three years. If the foreign producer is the majority partner, the film will only be considered Brazilian if the international partner grants permission for commercial exploitation by the Brazilian production company.

3 MULTILATERAL CO-PRODUCTION AGREEMENTS AND FUNDS

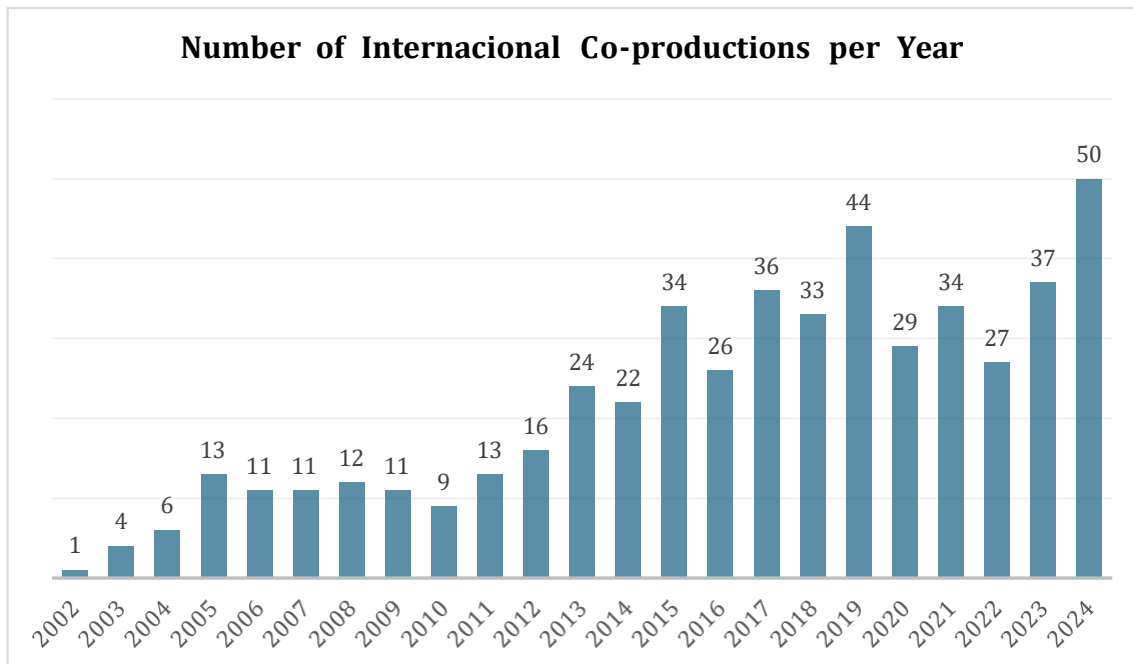
Brazil is a signatory of the [Ibero-American Cinematographic Integration Agreement](#), which aims to foster collaboration between countries in Ibero-America, promote cultural development, and create a common market for Latin American film productions.

The [Latin American Cinematographic Co-production Agreement](#) is the contract that formalizes film partnerships between the signatory countries of the agreement. As a result, films can be produced by two or more producers from two or more member countries, based on a co-production contract signed by the co-producing companies. Each co-producer must have a minimum participation of 20%.

Brazil is also a member of the [Ibermedia Program](#), an Ibero-American fund that supports the development of new projects through specific calls for co-productions, distribution, and circulation of fiction, animation, and documentary projects, produced by two or more production companies from Latin American, Portugal, or Spain.

4 BRAZIL INTERNATIONAL CO-PRODUCTIONS

Between 2002 and 2024, 503 Brazilian films were made in international co-productions. Over the past 13 years, the average has been 33 films per year, according to official data from the *Agência Nacional do Cinema* (Ancine). In 2024, there were 50 international co-productions, setting a historical record.



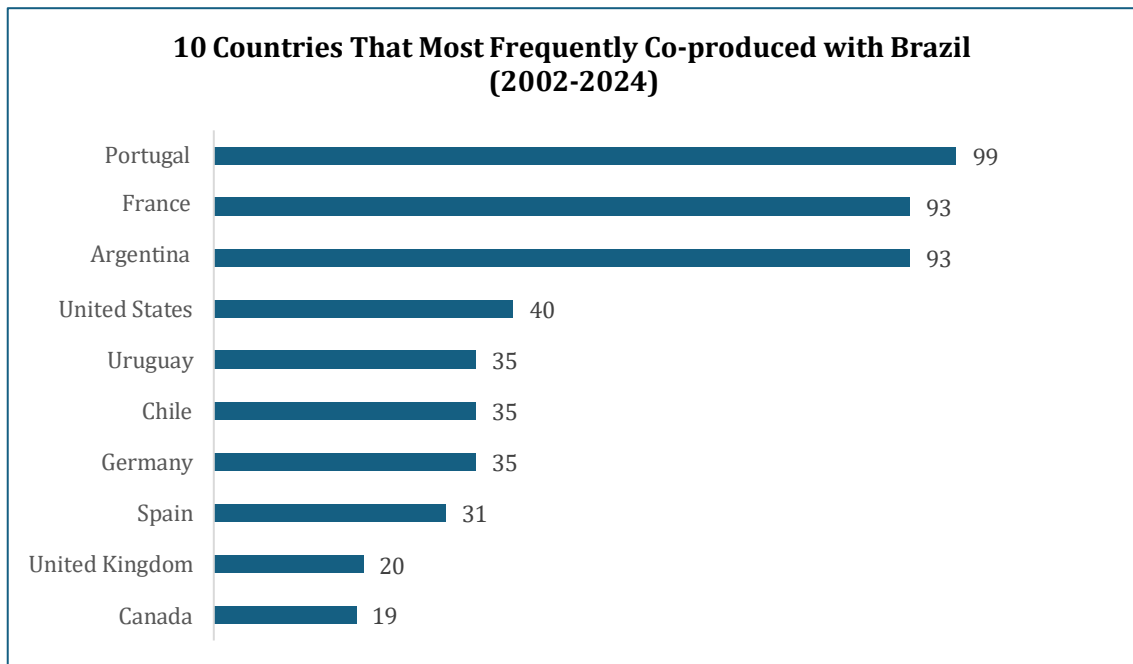

5 COUNTRIES THAT MOST FREQUENTLY CO-PRODUCE WITH BRAZIL

The three countries that have historically co-produced the most with Brazil are Portugal, Argentina, and France. From 2002 to 2024, this trend remained consistent, and they topped the ranking of the 10 countries with the most co-productions with Brazilian companies.

Following them are the United States, Uruguay, Chile, Germany, Spain, the United Kingdom, and Canada.

Among all these countries, the ones that have a bilateral co-production agreement with Brazil are more prominent, as these agreements simplify the process of securing financial resources and the bureaucratic procedures involved in any feature film production.

6 MAIN FUNDING SOURCES IN BRAZIL

Below are the list of most commonly used mechanisms as sources of funding in Brazilian cinema and audiovisual. To have access to these funds, international producers must form a co-production with a Brazilian production company. Only companies based in Brazil and officially registered in *Ancine* have access to these resources.

- **Fundo Setorial do Audiovisual (FSA) / Ancine**

Managed by *Agência Nacional do Cinema* (Ancine), FSA is the main Brazilian fund available to Brazilian producers and distributors. For the year of 2025, the FSA has more than R\$ 846 million available, which will be distributed through different funding calls.

- **Secretaria do Audiovisual (SAV) do Ministério da Cultura (MinC)**

In addition to Ancine, Brazil has *Secretaria do Audiovisual* (SAV), the public agency for audiovisual of the ministry of culture (*Ministério da Cultura* - MinC), responsible for promoting cinema and audiovisual productions, as well as the promotion and

diffusion of Brazilian projects. In partnership with Ancine and through the FSA, funding calls will be launched throughout 2025, distributed as follows: R\$ 100 million for Rio de Janeiro, R\$ 100 million for São Paulo, and an additional R\$ 300 million for productions from companies in the Central-West, North, Northeast, and the South.

- **Lei Paulo Gustavo (LPG) / MinC**

Established in 2022, the *Paulo Gustavo* law represents the largest federal investment ever made in Brazil's cultural sector. For film and audiovisual industries, R\$ 2.7 billion is allocated and distributed to Brazilian states and cities across the country. *Ministério da Cultura* (MinC) manages and distributes these resources.

- **Lei Aldir Blanc (LAB) / MinC**

Created in 2020 to minimize the impacts of the COVID-19 pandemic, this federal law is currently managed by *Ministério da Cultura* (MinC). It injects R\$ 3 billion annually into the cultural sector, distributed to states and cities across the country. Brazilian audiovisual producers can have access to funds specifically allocated for film and audiovisual production.

- **Programa de Ação Cultural (ProAC)**

This program, from the State of São Paulo, supports local production companies through both direct funding (calls for proposals) and indirect funding (tax incentive laws). A total of R\$ 100 million is allocated annually, with R\$ 54 million directed towards film and audiovisual production.

- **Pró-Carioca Audiovisual / RioFilme**

This is *RioFilme's* mechanism to stimulate film and audiovisual production in the city of Rio de Janeiro. The funding calls total R\$ 34 million, shared between feature film production, series, documentaries, games, and project development.

9 CASH REBATE

Two cities with the highest number of film and audiovisual production companies in Brazil, São Paulo and Rio de Janeiro, offer a cash rebate, which is a mechanism through which local productions can apply to get a portion of the amount invested in the film production back within the city.

São Paulo

In São Paulo the calls for proposals are offered by Spcine, and the rebate is intended for both foreign and national film productions with a broad international reach. The amount varies from 20% to 30% of the expenses for projects filmed or produced in the city and the state of São Paulo. To participate, it is mandatory to associate with a company based in São Paulo, either in the form of coproduction or production services.

Rio de Janeiro

Through RioFilme's public calls, producers can receive 30% of the amount spent on production to be invested in the city of Rio de Janeiro. If the city is the main location for the audiovisual project, this amount increases to 35%. To participate, it is mandatory to associate with a company based in Rio de Janeiro, either in the form of coproduction, production services, or licensing for the production.
